

**Aims and objectives**

2024 South American Mas-wrestling Championship among men and women in the absolute weight category is the official sport event of the International Mas-wrestling Federation and is held to promote and develop mas-wrestling in the world and solves the following tasks:

- determination the strongest mas-wrestling athletes;
- improvement of athlete's sportsmanship;
- strengthening friendly sporting relationship among countries.

**Date and venue**

Championship is held on October 18-21, in Rio de Janeiro, Brazil, on address: Arpoador, praça de praia do Diabo.

Arrival day – October 18, departure day – October 21.

**Competition Program: \***

***October 18 (Friday) - arrival day***

16:00 – 18:00 – commission on registration and admission of participants

19.00 – 19.30 – meeting of the Ground Jury with team representatives

***October 20 (Sunday) – competition day***

TBD – opening ceremony of championship

TBD – official drawing ceremony of participants

TBD – preliminary, semi-final and final bouts

TBD – awarding ceremony

***October 21 (Monday) – departure day***

**Management**

General management of preparation and holding of Championship is carried out by the International Mas-wrestling Federation, Brazil Mas-wrestling Confederation, State budgetary institution of the Republic of Sakha (Yakutia) «Republican Center of National Sports named after Vasiliy Manchaary», ANO «World Mas-wrestling Center» and Mas-wrestling Development Fund «Planet Mas-Wrestling».

Direct responsibility of holding the event carried on the Ground Jury, approved by the International Mas-wrestling Federation.

**Participation terms**

Allowed to participate athletes aged of 18 and over, passed medical examination and permitted to engage in power sports by the application of the National Mas-wrestling Federations or authorized bodies.

National Federations are recommended to include in their delegation a referee of the corresponding referee's category to work as part of the judging panel of the competition.

Participants are required to perform in sportswear in accordance with the rules of the International Mas-wrestling Federation.

### **Conditions for holding competition**

Competitions are of a personal nature and are held according to the current rules of the International Mas-wrestling Federation.

Depending on a number of participants in weight categories, changes are possible in the competition system according to the competition rules:

- for 6 or more athletes in the weight category according to the system with elimination after two defeats, divided into groups "A" and "B";
- for 5, 4 or 3 athletes in a weight category, a round robin system is used;
- for 2 and 1 athlete in a weight category, the weight category is added to the next weight category.

Weight categories:

- men - minimal weight - 90 kg;
- women - minimal weight - 75 kg.

The protocols on paper and electronic form should be given to the International Mas-wrestling Federation in two weeks after the sport event is over.

Participants grant organizers a right to take a photo, to film or otherwise use their voice, appearance and name. Further, the content can be displayed, distributed or otherwise used in merchandising and advertising to promote the sport in any media now known and possible in the future. The rights to be granted indefinitely and without additional compensation.

### **Insurance**

Participation in the competitions is allowed in case of presence of life and health insurance policy against accidents (original) for each person, which is submitted to the commission for registration and admission of participants.

Insurance fees of the athletes carry the sending organizations.

### **Safety**

Competitions to be held in sport buildings, agreeable to the standards of corresponding standard rules of law, functioning in the territory of Brazil and directed to provide public order and safety of participants and spectators, in the presence of acts of operational readiness of sports buildings for the activities, approved in the prescribed order.

Qualified medical personnel should present in the competition venue.

### **Financing**

All costs connected with the preparation and holding of competition, under the terms of the equity, carry the International Mas-wrestling Federation, Brazil Mas-wrestling Confederation, State Budgetary Institution of the Republic of Sakha (Yakutia) «Republican Center of National Sports named after Vasilij Manchaary», ANO «World Mas-wrestling Center» and Mas-Wrestling Development Fund «Planet Mas-Wrestling».

The costs of sending championship's participants (athletes, representatives, coaches, referees) including travel, accommodation, meals, insurance, visa costs to be carried by the sending organizations.

### **Awarding**

Absolute champions to be awarded with medals, diplomas and valuable prize.

## **Visa**

Delegations of countries that require a VISA to stay in Brazil must send to the organizers a list of participants in advance, attaching all comprehensive documents for visa processing.

## **Applications**

Preliminary applications with the obligatory indication of athletes, coaches and representatives number are submitted until October 1, 2024 on address:

Applications are submitted to the Commission for registration and admission of participants, signed by the head of the national federation and a doctor, as well as the following documents for each athlete:

- passport, certifying the nationality of the participant or a representing country's residence permit;
- life and health insurance policy against accidents (original).
