on holding World Mas-Wrestling Championship among boys and girls in the age category up to 18 y.o. - U18

REGULATION

on holding World Mas-wrestling Championship among boys and girls in the age category up to 18 y.o. - U18

Aims and objectives

World Mas-wrestling Championship among boys and girls is the official competition of the International Mas-wrestling Federation and held to promote and develop mas-wrestling in the world and solves the following tasks:

- determination the strongest mas-wrestling athletes among boys and girls;
- improvement of athletes sportsmanship;
- strengthening friendly sporting relationship among countries.

Date and venue

World Mas-wrestling Championship among boys and girls is held from November 28 to December 2 of 2024 in Bishkek, Kyrgyz Republic on address: Togolok Moldo Street 40, Sport Palace named after Kabaa uulu Kozhomkul.

Arrival day - November 28, departure day - December 2, 2024.

Competition Program: *

November 28 (Thursday) - arrival day

November 29 (Friday)

10.00 – 13.00 – work of Commission on registration and admission of participants;

14.00 - 17.00 – weigh-in and drawing of participants:

- boys 50 kg, 60 kg, 70 kg, 80 kg, 80+ kg;

- girls 50 kg, 60 kg, 70 kg, 70+ kg.

17.30 - 18.30 – meeting of the Ground Jury with team representatives.

November 30 (Saturday) - competition day

10.00 - 13.00 - preliminary bouts:

- boys 50 kg, 60 kg, 70 kg, 80 kg, 80+ kg;

- girls 50 kg, 60 kg, 70 kg, 70+ kg.

14.00 – 15.00 – opening ceremony of Championship

15.00 - 17.00 - semifinal and final bouts

17.00 - 18.30 - awarding ceremony

Management

General management of preparation and holding of Championship is carried out by the International Mas-wrestling Federation, Mas-wrestling Federation of Kyrgyz Republic, Physical Culture and Sports Department under the Ministry of Culture, Information, Sports and Youth Policy of Kyrgyz Republic, Directorate on non-Olympic Sports.

Direct responsibility of holding the event carried on the Organizing Committee on holding and preparation the VI World Mas-wrestling Championship and Ground Jury, approved by the International Mas-wrestling Federation.

Participation terms

Allowed to participate athletes of 2006-2008 year of birth, passed medical examination and permitted to engage in power sports by the application of the National Mas-wrestling Federations or authorized bodies, regardless of the continent. The age of athletes under 18 y.o. determines by date of birth on the competition day.

The National Mas-wrestling Federations are entitled to be represented up to 18 (eighteen) athletes, but no more than 3 (three) athletes in a weight category.

National Federations are recommended to include in their delegation a referee of the corresponding referee's category to work as part of the judging panel of the competition.

Participants are required to perform in sportswear in accordance with the rules of the International Mas-wrestling Federation.

The competition is held on a 24 cm high board.

Conditions for holding competition and determination of winners

Competitions are of a personal-team nature and are held according to the current rules of the International Mas-wrestling Federation.

Depending on the number of participants in the weight categories in the competition system, changes are possible according to the competition rules:

- for 7 or more athletes in the weight category according to the system with elimination after two defeats, divided into groups "A" and "B";
 - for 6, 5, 4 or 3 athletes in a weight category, a round robin system is used;
- for 2 or less athletes in a weight category, the weight category is added to the next weight category.

Weight categories:

- boys up to 50 kg, up to 60 kg, up to 70 kg, up to 80 kg, 80+ kg;
- girls up to 50 kg, up to 60 kg, up to 70 kg, 70+ kg.

The team total is displayed by points for the total number of medals:

1st place – 12 points, 2nd place – 8 points, 3rd place – 5 points.

In case of equal points among two or more team, priority is determined by most number of 1st, 2nd, 3rd, etc. places.

Participants grant organizers a right to take a photo, to film or otherwise use their voice, appearance and name. Further, the content can be displayed, distributed or otherwise used in merchandising and advertising to promote the sport in any media now known and possible in the future. The rights to be granted indefinitely and without additional compensation.

The final results (protocols) on paper and electronic form should be given to the International Mas-wrestling Federation in 2 (two) weeks after the event is over.

Insurance

Participation in the competitions is allowed only in case of presence a life and health insurance policy against accidents (original) for each person, which is submitted to the commission for registration and admission of participants. Insurance fees of the athletes carry the sending organizations.

Safety

Competitions to be held in sport buildings, agreeable to the standards of corresponding standard rules of law, functioning in the territory of Kyrgyz Republic and directed to provide public order and safety of participants and spectators.

Qualified medical personnel should present in the competition venue.

Financing

All costs connected with the preparation and holding of competition, under the terms of the equity, carry the International Mas-wrestling Federation, Mas-wrestling Federation of Kyrgyz Republic, Directorate on non-Olympic Sports, Physical Culture and Sports Department under the Ministry of Culture, Information, Sports and Youth Policy of Kyrgyz Republic, State Budgetary Institution of the Republic of Sakha (Yakutia) «Republican Center

of National Sports named after Vasiliy Manchaary», ANO «World Mas-wrestling Center» and Mas-Wrestling Development Fund «Planet Mas-Wrestling».

The costs of sending participants (travel, accommodation, meals, insurance, visa costs) are carry by the sending organizations.

Awarding

Top three athletes in each weight category to be awarded with medals, diplomas, and valuable prize.

Top three team to be awarded with diplomas and cups.

The national flag of the country, anthem on electronic media, nominal and technical applications signed by the head of the national mas-wrestling federation and a doctor, as well as the originals of the following documents for each athlete are presented to the commission for admission of participants to competitions:

- passport, certifying the nationality of the participant or a representing country's residence permit;
 - life and health insurance policy against accidents (original).

Visa

Delegations, which are needed VISA for entrance and stay on the territory of Kyrgyz Republic, should send to the organizers a list of participants until October 1, 2024 for visa processing, indicating full names, gender, passport numbers (also their dates of issue and validity), dates of birth, a scanned copy of the first informative page of the passport.

Marketing and advertising

The Organizing Committee guarantees maintenance of Sponsor rights by the partners and sponsors of the International Mas-Wrestling Federation, appointed in the appropriate Agreements.

Media

The Organizing Committee guarantees accordance of the appropriate conditions of work on the event for accredited media representatives in accordance with the Statement of the International Mas-Wrestling Federation on Mass-Media.

This regulation is the official challenge to the competition.
